



# End Homelessness

## The Issue

Homelessness and housing instability is a substantial problem that afflicts a diverse group of subpopulations in the United States. During the course of a year, nearly 1.5 million Americans experience homelessness for at least one night. Despite decades of efforts to stem the tide, the scope and persistence of homelessness in the U.S. has severe and lasting effects on the health and well-being of those affected.

## Societal Goal

With a focused yet reimagined approach to the issue that combines evidence, resources, innovative thinking, and political will, we can reduce the scope of homelessness in the United States as well as the risk factors such as housing and income instability that contribute to the issue.

## A Decade of Work

Over the next ten years, researchers, practitioners and policymakers can engage in a variety of activities that will advance this Grand Challenge and ignite social work achievements, including efforts to:

- Integrate data from PIT, HMIS, school districts and other sources such as foster care and healthcare systems to investigate the interconnected aspects and risk factors of homelessness.
- Expand access to affordable housing stock, housing subsidies, and housing choice vouchers.
- Link evidence-based psychosocial interventions to housing assistance programs for those in need.
- Promote policy change to address risk factors that increase likelihood of homelessness such as minimum wage, income disability benefits, and affordable housing.
- Adapt housing-led interventions with proven effective to new populations experiencing homelessness.
- Create innovative funding strategies that reform existing structures while also seeking new funding from sectors that previously have not been engaged.
